# **BEEF BY- PRODUCTS BUSINESS OPPORTUNITIES ALERT**



#### Introduction

The Local Enterprise Authority carried out a study on the Botswana Meat Commission by-products as part of its mandate to identify business opportunities for uptake by SMMEs in 2015. The main objective of the study was to identify potential uses of beef by-products produced by the Botswana Meat Commission that could be exploited by SMMEs for business opportunities. The study established that the Beef by-products have economic usage in the industrial, pharmaceutical, food manufacturing, leather and animal feed applications. At the time of the conduct of the study some of the by-products were either not being recovered or exported unprocessed while some were locked up in exclusive supply contracts. The key recommendations of the study were to lobby the Meat Commission to recover by-products of economic value and open up products in exclusive supply contracts. The removal of products from exclusive supply contracts were successful. As of 02 April 2025, the Meat Commission advertised several by-products for sale to the public thereby activating the potential opportunities.

## **Opportunities**

Table 1 shows the by-products currently being sold by the Botswana Meat Commission and their possible uses or products for manufacturing industry. According to the table, beef tallow and horns have the most multiple uses with potential to support diverse manufacturing industries. The recovery and availability of these raw materials locally presents manufacturing opportunities for the SMME sector subject to feasibility.

Table 2 shows the volumes of the most recent recovered by-products by the Botswana Meat Commission over a 3-year period between 2022 and 2024. According to the table, there was no recovery of calf serum in 2024, and no horns were recovered in 2022 and 2024. Beef bile was not recovered in the past three years and therefore does not appear on the table, but the Commission has indicated that it will be sold as and when recovered. Products that are consistently produced are bloodmeal, carcass meal, gallstones and tallow.
